Chamber Celebrates Accomplishments, Local Business Success and Distinguished Service

Roseburg, OR - The Roseburg Area Chamber of Commerce held its annual meeting of the membership and awards dinner on Thursday, March 24. Along with presenting its executive team for 2022, chamber leadership also shared the organization's activities and accomplishments during 2020 and 2021, as well as some of the chamber's key priorities for 2022 and beyond. The chamber's annual event celebrated Roseburg and Douglas County businesses and provided the chamber the opportunity to recognize business excellence and distinguished service of individuals in our community.

The Roseburg Area Chamber of Commerce board of directors is pleased to announce Tammy Turner from the Community Cancer Center will continue as chair of the board for 2022. Also holding leadership positions in 2022 are Gabe Crane of Roseburg Forest Products as vice chair and Sam Carter of Pacific Power as treasurer. They join Allen Pike, Hampton Inn & Suites, as the immediate past board chair and chamber president & CEO Debbie Fromdahl, as the five corporate officers for the Roseburg Area Chamber in 2022.

The Roseburg Area Chamber key priorities for 2022 are founded in its mission to serve, promote and protect the businesses of Douglas County. The chamber will continue its work to create a strong local economy; representing the interests of business through political advocacy; promote the community and our member businesses; and, of course, provide the quality programs chamber members have come to expect. In 2022, the chamber focused on defeating anti-business legislation and promoting pro-business legislation during Oregon's 2022 legislative session. The chamber will continue to participate in local and statewide coalitions for economic development and government affairs endeavors. Chamber priorities in 2022 include bringing all programs, events and committee back to in-person, implementing some new programs, expanding member and business resources and opportunities on the chamber's new website and launching new business councils.

During the evening's festivities, the chamber recognized three local companies for their excellence in business. The 2021 small business of the year award went to Gordon Wood Insurance & Financial Services. Douglas County Farmer's Co-op was recognized as the chamber's medium-sized business of the year for 2021, with Lone Rock Resources celebrated as the 2021 large business of the year award recipient. Board chair Turner shared that a future plaque at the chamber of commerce and the chamber website will list honorees for each category for every year the business of the year awards are presented. The exception will be for the year 2020. There was simply no way to choose one business over another in a year where businesses were fighting to get their doors open, keep their doors open, keep

workers employed, keep customers and employees safe, all while managing ever-changing operating mandates; a year where many businesses were fighting for survival. And, so, for the year 2020 under each category...small, medium and large business of the year...it will read, "Every Douglas County Business."

Since the pandemic postponed and, ultimately, shuttered the chamber event last year, the chamber recognized its first citizens for both 2020 and 2021. Sue Van Volkenburg and Steve Loosley received 2020 First Citizen honors for their longtime service and outstanding volunteer activity in our community. Loosely was recognized as a true servant leader whose community volunteerism included the YMCA, Casa de Belen, the Community Cancer Center, Southern Oregon Goodwill, the Legion Field turf project, Umpqua Community College board of trustees and more.

Van Volkenburg previously served on the Roseburg Chamber board of directors and a number of chamber committees. She has a long service association with Battered Persons Advocacy, LeTip, and local youth sports to include the Cal Ripkin board and coaching girls' volleyball. A Roseburg Rotarian for more than 16 years where Van Volkenburg's service includes "being Mama Duck" and a Rotary Youth Exchange Officer, where she's been instrumental in coordinating both local youth exchange and setting up hosting families for international exchange students.

Andrea Zielinski and Dave Leonard were honored as the chamber's 2021 First Citizens. Zielinski was recognized for service as a Roseburg city councilwoman since 2015, including chairing the Historical Review and Roseburg Library commissions. She serves on the boards for the Family Development Center, Greater Douglas United Way and Douglas Country Traffic Safety Commission. She volunteers time and talents to both the Music on the Half Shell committee and Friends of Umpqua Valley Police K9 programs committee. Zielinski is a Roseburg Chamber Project Leadership graduate.

Leonard was honored for his more than 30 years of volunteer service in our community. He served on the Mercy Medical Center and Mercy Foundation board of directors, four years as Mercy Medical Center's chairman. Leonard served on a variety of commissions and board for the city of Roseburg and Douglas County. Generous with his professional expertise as an engineer, Leonard is also known for designing the Marion Carl Memorial at the airport, Saving Grace Pet Adoption Center, the Half Shell Amphitheater, Fish Ladder at Winchester Dam, Children's Fort at River Forks Park and more projects throughout Douglas County than can be counted. Leonard also served on the Roseburg Chamber board of directors and chamber Foundation board, serving as the chamber's chair of the board in 2002.

- Became the "go to" business resource for COVID-19 pandemic information and resources through its online "Covid-19 Business Resource & Recovery Center Library," expedient membership email blasts with essential information related to the pandemic and responding to phone and email inquiries from both member and non-member businesses
- Partnered with the city of Roseburg to provide needed PPE to Roseburg-area businesses
- While at time necessary/required to have the building closed to the public, chamber staff worked on-site on behalf of Douglas County businesses daily throughout the pandemic. The chamber did not close during 2020 or 2021
- Due to long-term, conscientious management of chamber funds, including ensuring adequate emergency operating reserves, the chamber remained operational and worked to protect the interests of business and fulfill its obligations to its members, despite the inability—due to the pandemic—to generate non-dues revenue
- The Roseburg Area Chamber of Commerce remains financially stable and secure
- Continued progressing the 2019-20 Public Affairs & Legislative Agenda, specifically during the 2020
 Oregon Legislative Session and 21-22 Agenda during the 2021 session, to oppose anti-business legislation and support pro-business legislation
- Hosted State of the County, Legislative Preview, State of the Timber/Wood Products Industry and other programs in-person and virtually in 2020, a virtual State of the County in early 2021, with in-person membership meeting programs returning in November 2021
- Represented the interests of business with government monitoring federal, state and local political activity, taking positions when appropriate, with an emphasis on lessening and eliminating mandates to get our businesses fully open and advocating for short-term and long-term financial support and restoration
- Provided membership political awareness, especially during both the 2020 and 2021 Oregon legislative sessions, via newsletter articles, "Call to Action" emails, and in-person and virtual membership meetings
- Increased social media posts, member email blasts and website updates
- Continued to upgrade and expand chamber communications, specifically its electronic newsletter, "Chamber News" emails and "Calls to Action"; produced six editions of Business Perspectives in addition to expanding current news on website
- Hosted the 66th meeting of the membership and awards dinner in January 2020, presenting RACC's awards for business recognition program at the event

Our Vision:

To advocate for and be the voice of the business community in the greater Roseburg area

Our Mission:

To strengthen, enhance and protect our members through political advocacy, economic development, community promotion and member programs and services

Roseburg Area Chamber of Commerce priorities are consistently reviewed to best serve local business, with special focus in 2022 related to pandemic/post-pandemic emergence. Some key priorities for 2022:

- Advocate for business during Oregon's 2022 Legislative Session and advance RACC's 2021-2022 Public
 Affairs & Legislative Agenda, participate with local, regional and statewide coalitions to oppose antibusiness and support pro-business initiatives, with specific focus on short and long-term assistance for
 business adversely impacted by pandemic shutdowns and for liability protections during and post-COVID.
- Where deemed appropriate and/or necessary, endorse candidates for local and state races based on the chamber's established criteria and candidate's pro-business voting/track record.
- Local business "go-to" for information and resources related to the pandemic and post-pandemic recovery. Timely distribution of information to business members via email blasts, social media and website updates. No-cost PPE distribution to area businesses through partnership with the city of Roseburg.
- Create business resource libraries for emergencies/catastrophes (i.e. Coved, wildfires) and for general best business practices. Future, add "member-only" access.
- Monitor issues and activities at the local, state and federal government levels. Actively support and oppose issues in order to advance the most pro-business environment possible. Hold regular meetings with elected officials.
- Keep membership informed of government affairs issues, particularly during Oregon's Legislative Session via newsletter articles, broadcast "Call to Action" emails, membership email blast updates, website "Current News," and programs/forums, as needed.
- Expanding member outreach and interaction including quarterly "9 at 9" with members. Increase business visitations and retention activities.
- Meet with local businesses to survey needs and barriers related to business retention and future potential expansion for our businesses, and to foster family-wage job creation and economic growth.
- Advocate for effective forest management on public lands to include increased harvest and reforestation, imperative to economic growth, long-term sustainability, and to curtail the significant increase in catastrophic wildfires seen in recent years; and advocate for proper management after a fire or other catastrophic event.
- Promote member businesses products and services through referrals, online member directory and printed directory, advertising opportunities, social media posts, "Shop local" promotion and member brochures on information floor.
- Launch new business councils this fall: Douglas County Lodging Industry, Douglas County Manufacturing Industry and Douglas County Retail Industry councils, others as needed.
- Programs/events priority one is getting back in person; consider new annual membership meeting/awards format, After Hours, complete Project Leadership 2021-22 and launch 2022-23, membership meeting programs with new component in February (2023) and back-to-back with Economic Forecast program in November.
- Promote our community as the best place to live, work and visit through onsite informational displays, online recreation, events and amenities information, statewide distribution of InUmpqua publication and Roseburg/Douglas County map; Land of Umpqua Facebook page and visitors/information center. Provide information to individuals and businesses looking to relocate through online, phone, email, mail and on-site inquiries and mailing of relocation information packets.

Since 1921, Douglas County Farmers Co-op has been supporting and growing with Douglas County's community. The Co-op has had several names and moved around town (most noticeably after the Co-op was leveled in the 1959 Blast). This business was once a small business with a pretty specific customer. Over the years, DC Farmers Co-op has grown in size, locations, product offerings and customer base, all while never forgetting their core clientele. Having celebrated its 100th anniversary last year, the Roseburg Area Chamber's medium-sized business of the year has been serving Douglas County ranchers, farmers and homeowners since 1921, and will continue to do so long into the future, especially with the anticipated completion and opening of a new location in Winston later this year. The Co-op offers a full line of feed and farm supply products, an expansive lawn and garden department, wide assortment of equine, livestock and pet supplies, and so much more. Their motto is, "Good people, good products, good advice." But, let's be honest, for many of us it's all about spring time and the arrival of the baby chicks!

Lone Rock Resource was founded by Fred and Frances Sohn. Fred emigrated from Germany as a young man in 1936, eventually making his way to the Pacific Northwest with wife, Frances. In 1950, the Sohns built a sawmill on the banks of the S Umpqua River. Fascinated with technology, Fred hired the best talent and used innovation to differentiate his company in the competitive world of post-World War II lumber manufacturing.

Over the next 50 years, Fred's passion for innovation would change mill production worldwide. Taking the unprecedented step of assembling an electronics research team, Fred created the industry's first fully computerized sawmill and later patented 3-D scanning technology to maximize log recovery. Today, every production mill in the world relies on that computer technology. Fred's zeal for finding a better way extended to forest management as well. In the 1970s, the company aggressively began buying cut-over lands and restoring them, planting up to 1 million seedlings a year.

The 1990's were a time of transition. Two of Fred's five sons, Howard and Rick, moved into company leadership positions as the family and the company looked to the future. Continued investment in manufacturing was matched with significant additions to the forest land base. Company land holdings more than doubled over a 10-year period.

Transitions continued as a new century began. In 2001, the Sohn family moved away from its manufacturing foundations selling it's sawmill and veneer plant. Fred retired and his sons assumed leadership of the company focusing on its forest lands. The culture Fred established through investment in people, research, equipment, and technology remain integral to the company's success today.

Rick Sohn's retirement as president in 2008 marked a successful transition to non-family leadership. The board expanded to include directors with experience managing family businesses, as well as welcoming third-generation Sohn family members.

Today under President and CEO Toby Luther, Lone Rock is a balanced and diversified real assets and natural resources investment company. This family-owned business is not only a standout leader in its industry, but the organization's support of business, industry, local non-profit organizations; and, community and youth activities, is unparalleled. Lone Rock encourages its employees to be involved in our community resulting in the active participation with more than 40 local non-profit organizations, programs and events. During the 2020 Labor Day fires, this industry leader had 72 employees with nearly 7000 hours over 10 days, working to help contain the Archie Creek fire. Also deserving mention is Lone Rock's aggressive diversification strategy, a diversification that added wine and Abby's Pizza, under their already distinguished and respected brand.



Our 2021 female First Citizen is known as a dedicated community volunteer, not just by the pages-long list of community involvement, but by her infectious, visible enthusiasm and desire to make our community stronger and better, and to enhance the lives of every citizen in the greater Roseburg area.

Words and phrases used by others to describe our honoree include, "kind-hearted, selfless, passionate and reliable." She possesses the talent of bringing out the best in others.
