Annual Awards Banquet Celebrates Business and Service to Community

“Roseburg Works,” the Theme of the Evening

The Roseburg Area Chamber of Commerce has a number of priorities for 2017 on behalf of Douglas County business that we can't wait to share. On Thursday, January 26 the chamber will celebrate our local business community at the 63rd annual membership meeting and awards banquet. This year's theme is, “Roseburg Works.”

The evening reception begins at 6:00 p.m. with dinner at 7:00 p.m. Tickets for the event remain \$65 per person and \$625 for a table of 10. The chamber is currently accepting reservations from our members purchasing a full table for the banquet only. Full tables have priority placement. Reservations and payments will be accepted by telephone or in person at the chamber of commerce after January 9. Purchase of individual tickets and partial tables will also be available after January 9.

The festivities of the chamber's annual banquet will include the ceremonious passing of the gavel from immediate past board chair Kent Rochester to 2017 board chair Angela Brown. The chamber's 2017 leadership team will be introduced. Highlighted during the evening's program will be the presentation of the organization's priorities for 2017 and the, always entertaining, activities and accomplishment video for the past year.

Message from President / CEO

Just When We Start to Breathe a Sigh...

Business came together for some pretty significant successes in 2016....not the least of which was in the unified grassroots defeat of Measure 97. We also suffered some setbacks—minimum wage for one—that will have a long and lingering adverse affect on Oregon businesses.

While we will touch on these issues, much will be put aside on January 26, as we unite in a celebration of business at the chamber's annual membership meeting and awards banquet. The theme for the evening is "Roseburg Works" . . . because, we do! For more information about the annual awards banquet, please see the story on page 1, flyer or click below for tickets.

We'll set aside January 26 to celebrate business. But, before that and, especially the day after, the chamber will be back to work on behalf of the Douglas County business community. Much of our focus will be on the 2017 Oregon Legislature. The list of "taxing" pre-bills released in December has Oregon citizens and businesses running for cover.

Just a couple of areas where Oregon House and Senate leadership are looking for more revenue is with proposed homeownership tax, cow tax, farmer tax, conservation tax, victims of crimes tax, forest tax, struggling business

tax, tax hikes for C-Corp businesses and S-Corp businesses even if they lose money, to name a few. Both the Senate Finance and Revenue and the House Revenue committees are looking at a repeal of Ballot Measure 50, a Constitutional Amendment, passed by the citizens of Oregon in 1997, limiting property taxes through restrictions on assessed value of property and property tax rates.

These examples of what are being proposed in Salem is just a drop in the proverbial bucket despite the fact that Oregonians overwhelmingly rejected Measure 97 this past November and, that the state of Oregon has \$1.3 billion in new revenue in the next biennium. This represents an 8.3% increase from 2015 to 2017.

The Roseburg Area Chamber of Commerce will join with other chambers, businesses and business organizations around the state to make sure the voice of business and rural Oregon is heard during this year's legislative session.

This, however, is only one of the chamber's priorities for 2017. To learn more, be sure to attend the chamber's annual awards banquet on January 26, check out next month's edition of *Business Perspectives* and attend our legislative conference calls beginning February 15.



Legislative Conference Call

During the 2017 Oregon legislative session, the Roseburg Area Chamber of Commerce will host conference calls with the five members of our county's delegation in Salem on the first and third Wednesdays of each month. These conference calls are an incredible opportunity for our members to hear firsthand about what's happening in Salem during the session and to be sure our delegation is aware of local business positions on potential legislation.

Our first discussion with legislators is scheduled for Wednesday, February 15, 2017. The calls are held in the chamber conference room. 
