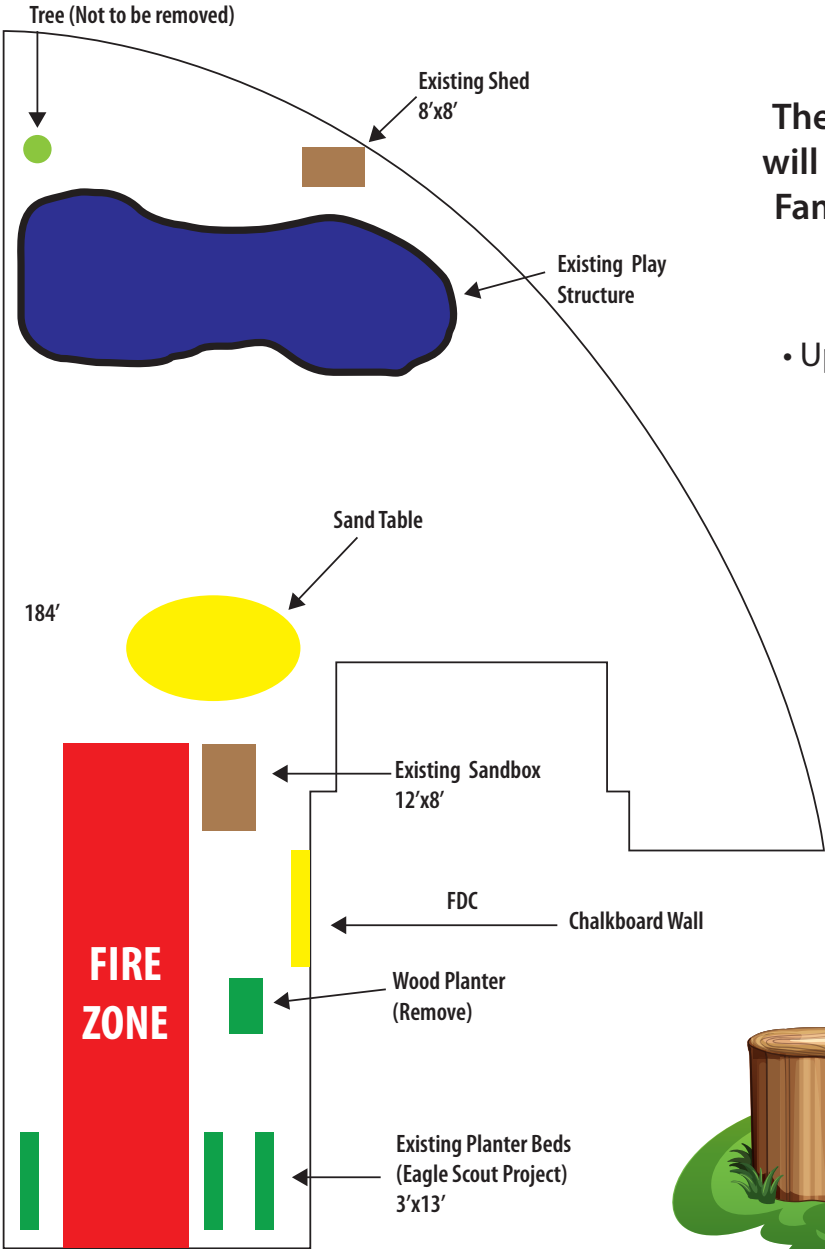
THE PROJECT:
