A Must for Future Business & Community Leaders

The Roseburg Area Chamber is accepting applications for 2021-22 Project Leadership Roseburg. If you or one of your employees are future Douglas County business leaders, then enrolling in Project Leadership is a must! The chamber is very proud of this long-standing program and this year marks the 32nd year! The chamber has graduated near 650 future leaders from this distinguished professional development program.

Not your typical leadership program, Project Leadership Roseburg provides participants with comprehensive insight of Douglas County and an understanding of how our community works directly from business and community leaders from all over the county. The nine-month program includes four special events and eight "workshops" that range from one-on-ones, panel presentations to numerous facility tours to gain knowledge about our region. The program fosters dedication to our community as participants learn about how they can get involved to help create a more vibrant future for Douglas County.

Project Leadership Roseburg is a two-year commitment for participants; the first year as participants and the second year supporting chamber staff with facilitation of a workshop session for a new year of Project Leadership program participants, thus fulfilling the second-year commitment to the program.

Workshops focus on a variety of subjects and many include leadership and teambuilding activities. Subjects include in-depth glimpses at economic drivers such as natural resources, manufacturing, tourism, education and health care industry, to name a few. Participants will be the chamber's guests at Economic Forecast 2022 and membership meeting lunch in November, the annual awards dinner in March and, of course, graduation at next May's membership luncheon.

The Roseburg Area Chamber is currently accepting applications. Please keep in mind space is limited. Applicants may be either employer or self-sponsored. The cost for the program is \$700 for members of the Roseburg Area Chamber and \$925 for non-members. Roseburg Area Chamber members are given priority. Acceptance is on a first-come, first-approved basis.

And, if you're planning ahead, next year the chamber's annual celebration of business, membership meeting and awards dinner will be held on Thursday, March 24, 2022.

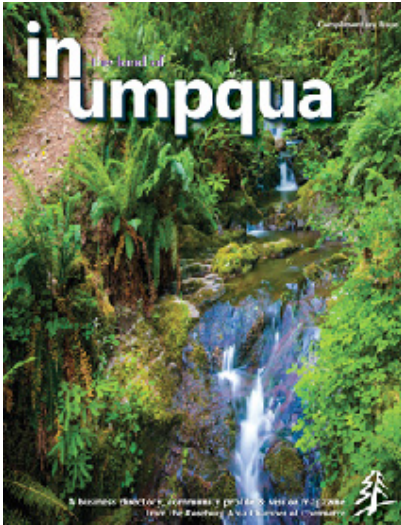

Since 1989, more than 600 business men and women have graduated from Project Leadership Roseburg, and many of today's respected Douglas County business and civic leaders are graduates of this esteemed program. Now in its 32nd year, the mission of the Roseburg Area Chamber of Commerce's leadership program is to educate, inspire, and strengthen community-minded individuals through increased business and community awareness and to promote civic activism through volunteerism.

Not your typical leadership program, Project Leadership provides participants with a comprehensive awareness of the many facets of Douglas County and they gain a deeper understanding of how our community works, directly from its leaders. The nine-month program not only imparts knowledge about our region, but fosters dedication to our community as participants learn about opportunities for involvement to help create a more vibrant future for Douglas County.

Making a Commitment to Leadership

Project Leadership Roseburg requires a two-year commitment from participants. During the first year, participants attend eight day-long sessions per month. Each month, participants will attend a full-day workshop, panel presentations/briefings, and/or tours on different session topics.

Project Leadership challenges its participants to become more involved in local politics, the chamber, community and civic organizations—all for the future betterment of Douglas County. This involvement will start soon after participants "graduate" from the leadership program in May. They may assist chamber staff with facilitation of workshop sessions for a new class of Project Leadership participants; thus, fulfilling their second-year commitment to the program.
