## **January 1 is Almost Here...Are You Ready for Oregon's New Paid Leave Program?**

The chamber's November membership meeting lunch program discussed Oregon's new paid family and medical leave insurance program which starts January 1, 2023. Oregon employers, whether

required to financially contribute or not, have mandated actions and responsibilities related to the “Paid Leave Oregon” program.
