

ACTION ALERT! Support SB 795

SB 795 would allow Forest Trust Land counties to determine their own economic future. Public hearing Monday - MAKE YOUR VOICE HEARD

Legislators need to hear from local businesses in rural Oregon on <u>SB 795</u> and the importance of utilizing our natural resources to protect rural economies and benefit our citizens.

As you may know, the Oregon Board of Forestry is moving forward with the Western Oregon State Forests Habitat Conservation Plan (HCP). The HCP would reduce nearly 35% of the timber harvest in state forests and have a major impact on counties that receive and depend on timber revenue to support their local communities.

Oregon's Forest Trust Land counties face a potential loss of millions of dollars for the wood products industry which will further hurt local governments, jobs, and essential services like public safety. **SB 795** seeks to return these state forest lands to counties to be managed by local governments for the benefit of their citizens and economies.

A jury has already determined that counties are missing out on over \$1B in revenue due to state mismanagement of forest lands. A jury awarded damages in 2021. However, the Oregon Appeals court threw out the verdict and the Oregon Supreme Court refused to hear the case.

That's why SB 795 is needed. <u>SB 795</u> returns state forest lands back to the counties that want them and can manage them for the benefit of their citizens. It returns power and economic self-determination back to our Forest Trust Land counties.

A public hearing on SB 795 will be held in the <u>Senate Committee on Natural Resources</u> on Monday, February 27th.
