Dori John and Toby Luther received First Citizen honors for their longtime service and outstanding volunteerism in our community. John was recognized for her service and commitment to area youth including serving on numerous program/project teams and the board of directors for both the Boys & Girls Club of the Umpqua Valley and YMCA of Douglas County.
