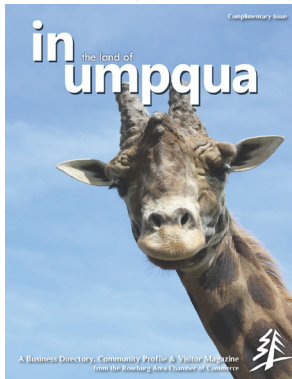

Chamber Leadership Program Building Next Generation of Community Leaders

Applications Being Accepted for 2023-24 Project Leadership Roseburg

The chamber's Project Leadership Roseburg gives participants a behind-the-scenes look at Roseburg and Douglas County, providing comprehensive insight of how our community works directly from business and community leaders from throughout the county.

The nine-month program includes four special events and eight "sessions" that range from one-on-one interaction, panel presentations to tours, expanding knowledge about our region. The program nurtures community involvement as participants learn about the importance of volunteerism to create a vibrant future for Douglas County.

Project Leadership Roseburg is a two-year commitment for participants. The first year as participants and the second year supporting chamber staff with facilitation of a workshop session for a next group of Project Leadership participants.

Workshops focus on a variety of local industry, public and non-profit sectors. Subjects include in-depth glimpses at economic drivers such as natural resources, manufacturing, tourism, education and health care industry, to name a few. Participants will attend Economic Forecast 2024, the November membership meeting lunch in November, the annual awards dinner in March of 2024 and, of course, graduation at the May 2024 membership luncheon.

If you, or one of your employees, are a future business and community leader, enrolling in Project Leadership is a must! The Roseburg Area Chamber is very proud of this long-standing program and this year marks our 34th year! The chamber has graduated 650 future leaders from this distinguished professional development program.

The Roseburg Area Chamber of Commerce is currently accepting applications. Please keep in mind space is limited. Applicants may be employer-sponsored or self-sponsored. The cost for the program is \$750 for members of the Roseburg Area Chamber and \$950 for non-members. Roseburg Chamber members are given priority. Acceptance is on a first-come, first-approved basis.

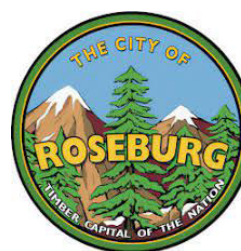

Are you or one of your employees a future Douglas County business leader?

Now is the time to apply for participation in the 2023-2024 Project Leadership Roseburg program.

Since 1989, more than 600 business men and women have graduated from Project Leadership Roseburg, and many of today's respected Douglas County business and civic leaders are graduates of this esteemed program. Now in its 34th year, the mission of the Roseburg Area Chamber of Commerce's leadership program is to educate, inspire, and strengthen community-minded individuals through increased business and community awareness and to promote civic activism through volunteerism.

Not your typical leadership program, Project Leadership provides participants with a comprehensive awareness of the many facets of Douglas County and they gain a deeper understanding of how our community works, directly from its leaders. The nine-month program not only imparts knowledge about our region, but fosters dedication to our community as participants learn about opportunities for involvement to help create a more vibrant future for Douglas County.

Making a Commitment to Leadership

Project Leadership Roseburg requires a two-year commitment from participants. During the first year, participants attend eight day-long sessions, one per month. Each month, participants will attend a full-day workshop, panel presentations/briefings, and/or tours on different session topics.

Project Leadership challenges its participants to become more involved in local politics, the chamber, community and civic organizations—all for the future betterment of Douglas County. This involvement will start soon after participants "graduate" from the leadership program in May. They may assist chamber staff with facilitation of workshop sessions for a new class of Project Leadership participants; thus, fulfilling their second-year commitment to the program.

Now Accepting Applications

The chamber is currently accepting applications for the 2023-24 Project Leadership class. Space is limited. Applicants may be employer-sponsored or self-sponsored. The cost for the program for Roseburg Area Chamber members is \$750; the cost for non-member participants is \$950.

Roseburg Area Chamber members will be given priority and acceptance is on a first-come/first-approved basis. Only one candidate per company may be accepted.

The member company/organization understands that the content of their advertisement, flyer, website banner or any other promotional material is to promote their company—its products, services or special business event.

Under no circumstances will member-paid advertising, flyer inserts, banner ads and/or a sponsor's/host's promotional materials be accepted by the chamber that is political, religious or fundraising in nature. Mailing labels will not be sold for such purposes.

No member-paid advertising, flyer inserts, banner ads and/or sponsorship/host's promotional material will solicit funds, sponsorships or memberships.

No member-paid advertising, flyer inserts, banner ads and/or sponsorship/host's promotional material shall direct to a website or direct readers to contact an organization or agency if the purpose is to solicit any of the aforementioned.

A member's flyer, advertisement or promotional materials may promote an event so long as it is restricted to promotion of event sans previous restrictions and is exclusively the member's business event. A member will not promote an event of another.

No flyer, advertisement or promotional materials should promote any entity other than the member placing the flyer, ad or promotional materials. Only in exceptional instances and with the advance approval of RACC president/CEO, a member placing a flyer may thank or recognize sponsors or contributors that are RACC members. Under no circumstances, will non-chamber members be promoted.

Reservations for advertisement placement or flyer insertion must be made on or before the 12th of the month before newsletter publication. Flyer space is limited. If the reservation for flyer is cancelled by the 12th of the month there will be no charge. If a flyer insert reservation is cancelled after the 12th of the month, the member will be charged \$200 for holding the space.

A graphic file (.pdf, .tif, .jpg, etc.) of the advertisement or flyer will be supplied to the chamber on or before 15th of the month prior to insertion.

Members requesting membership mailing labels will sign an agreement confirming and accepting the chamber's restrictions on use before labels will be produced. Label production will be three to five days after receipt of the signed agreement.

The chamber reserves the right to refuse to publish any advertisement, flyer or banner ad it deems not to be in compliance with policies, positions or mission or to refuse sale of member mailing lists or sponsorship/promotional opportunities if it deems the same lack of compliance.
