Smith's background is in public policy and communications, having worked in the Oregon Legislature in various capacities and having served several members of leadership in the House of Representatives. He founded Healthy Forests, Healthy Communities in 2013, a non-profit, nonpartisan grassroots coalition that advocates for active forest management on federally-owned lands.
