[Get Tickets Now!](#) The program at the chamber's November 18 membership meeting lunch will be a presentation discussing the Exit 124/125 Interchange Area Management Plan and Garden Valley Corridor Plan. The Oregon Department of Transportation and the City of Roseburg are working together on the plan. For Exits 124 and 125, an Interchange Area Management Plan (IAMP) will outline a 20-year vision for access and roadway improvements to protect the function and operations of the interchanges. The Garden Valley Corridor Plan (GVCP) will identify strategies for the City to improve safety, mobility and connectivity so the corridor better serves our community's needs now and into the future. Prior to joining Oregon Rogers REALTORS® Rogers spent more than a decade working with leaders in the manufacturing, technology, health care and energy sectors to identify and solve public policy challenges affecting business and economic development in Oregon. Smith's background is in public policy and communications, having worked in the Oregon Legislature in various capacities and having served several members of leadership in the House of Representatives. He founded Healthy Forests, Healthy Communities in 2013, a non-profit, non-partisan grassroots coalition that advocates for active forest management on federally-owned lands.
