## **Economic Forecast 2025**

The Roseburg Area Chamber of Commerce's Economic Forecast 2025 will review this past year and the economic impacts on our

businesses, county and state. Our panel of experts will explore the issues, political climate and take a peek at specific industries impacting our local economy. Be There for Final Membership Meeting Lunch of 2024

The program at the chamber's November 18 membership meeting lunch will be a presentation discussing the Exit 124/125 Interchange Area Management Plan and Garden Valley Corridor Plan. The Oregon Department of Transportation and the city of Roseburg are working together on the plan. For Exits 124 and 125, an Interchange Area Management Plan (IAMP) will outline a 20-year vision for access and roadway improvements to protect the function and operations of the interchanges. The Garden Valley Corridor Plan (GVCP) will identify strategies for the city to improve safety, mobility and connectivity so the corridor better serves our community's needs now and into the future. # **VOTE NO on Measure 118**

A "NO" Vote is in Support of All Our Local Businesses & Citizens

As you read in our September/October newsletter, the Roseburg Area Chamber of Commerce is an active participant of the growing coalition of businesses, consumers and organizations from across the state in opposition to Measure 118. If passed, Measure 118 would impose the largest tax increase of any kind in Oregon history. The Legislative Revenue Office (LRO) estimates that the tax on Oregon sales would collect in excess of \$6.8 billion per year by imposing a 3%

tax on a corporation's sales above \$25 million annually. This proposal is a gross receipts tax that applies to sales, not profits. Businesses would have to pay even if they were making a small profit, or no profit at all.

If you need the outreach toolkit, yard signs, business window signs or other "NO on 118" collateral material, please email Debbie at the chamber. The coalition's newest TV ad highlights several ways in which Measure 118's \$6.8 Billion annual tax on sales would increase costs for basic necessities like utilities, home and car insurance, gasoline, internet service, medicine, food and health care. ## **VOTE in Support of Local Business**

By Voting for RACC-Endorsed Candidates in State & Local Races

The Roseburg Area Chamber of Commerce board of directors was unanimously in its endorsement of four candidates vying for public office in this November's general election. The chamber's endorsements include two incumbents in state legislative races and one incumbent and one challenger seeking Roseburg city council seats.

In Oregon legislative races, the chamber endorsed the honorable David Brock Smith, incumbent, in his reelection bid to Oregon Senate, District 1 and the honorable Virgle Osborne, incumbent in the Oregon House of Representatives, District 2. While these two sitting legislators met all of chamber metrics for endorsement, the chamber's support is, first and foremost, because these public servants have earned and maintained the chamber's confidence by their support of Douglas County businesses during their time in the Oregon Legislature. The chamber considers a number of criteria when endorsing incumbents, with the greatest weight given to the legislator's voting record and active engagement with the Douglas County business community.

To round out its 2024 candidate endorsements, the chamber conducted a formal candidate review and interview process for Roseburg city council races. The chamber does not endorse in every race, but does weigh in when there is a clear and compelling reason to do so.

written questionnaires and conducts in-person interviews as part of the candidate review process. The chamber's highest measure is given to a candidate's proven support of local businesses in alignment with the chamber's pro-business positions. The Roseburg Area Chamber of Commerce endorses candidates in two contested Roseburg city council races, determining there was an undeniable need to do so in support of our local

There are a number of conditions and criteria considered in Roseburg Area Chamber of Commerce's candidate endorsements. Chamber leadership reviews voting records, responses to

business community. The chamber endoses challenger Katie Williams in her bid for the Ward 1, Position 2 seat on Roseburg city council. The chamber also endorses incumbent Andrea Zielinski in her re-election bid for Roseburg city council, Ward 2, Position 2.

All of these endorsements also reflect board criteria related to electability, candidates' existing relationships with local businesses and business organizations and a willingness to maintain a positive working relationship with chamber leadership and local business. These individuals have the chamber's confidence and full support.

The Roseburg Area Chamber looks forward to working with members of our local delegation during the 2025 legislative session and with Roseburg city councilmembers on local issues, on behalf of our businesses. 
