Still Time to Apply for Flood Damage Assistance

SBA customer service representatives are still on hand at the Disaster Loan Outreach Center (DLOC) located in the Roseburg Public Safety Center, third floor (Rm 303), 700 SE Douglas Avenue to answer questions about SBA's disaster loan program, explain the application process and help complete applications for those affected by severe storms, flooding, landslides and mudslides March 13-20, 2025. DLOC is currently open Monday through Friday, 8:00 am to 4:30 pm. Walk-ins are accepted, but you may schedule an in-person appointment in advance at appointment.sba.gov.

To apply online, visit sba.gov/disaster. Applicants may also call SBA's Customer Service Center at 800-659-2955 or email disastercustomerservice@sba.gov for more information on SBA disaster assistance. For people who are deaf, hard of hearing, or have a speech disability, please dial 7-1-1 to access telecommunications relay services.

The deadline to return physical damage applications is **August 25, 2025**. The deadline to return economic injury applications is **March 24, 2026**. Please share this information with others who may have been impacted by the March storms.
