

Compliance with New/Updated State & Federal Employment Laws

One week left to GET YOUR TICKETS! With noteworthy changes in 2025, and more to come 2026, to both federal and state employment/labor laws, Oregon employers face new regulations regarding leave, pay equity and hiring practices, with penalties for non-compliance growing stricter. These updates affect our local employers, from rules about internal investigations and age discrimination to new liability mandates for contractors. Employers should attend the Roseburg Area Chamber's October 20 membership meeting lunch for important information about keeping in compliance with new and updated state and federal laws.
